- 1. **Update of the GMH programme**, this has expanded to 11 junior classes and 3 adult classes per week with 2019 sessions already filling up fast. Very few children are competing but the number training more than once a week has increased. Pointed out the need to keep communication going between the venues and that there had been some IT issues which wasn't a coaches role to sort out. Noted that the courts would need to be resurfaced soon. We are nearing the capacity limit of what can be done at GMH given that it is only a two court site.

7. Summary of the Year and 2019

Financial issues and continuing lack of clarity around Southwark Council's plans did affect the tennis programme. Trying to provide 1:1 support for children competing at higher levels as this requires individual technical work but it is expensive. Norton Rose Fulbright have stopped their support for the six sports clubs in Southwark which has impacted Be Active financially.

- a. Player results highlights were Mukhtar gaining an ATP world ranking and Jesse being picked for GB Boys 12 U team. Juniors have won 11 Grade 5 or higher tournaments so far this year.
- b. Team Tennis mixed 10U and mens teams won promotion. Women's team didn't get to play a match due to withdrawals and cancellations.
- c. Club championships a cut down version was held for the juniors in July.
- d. Team Challenge GMH children came down to Burgess Park for a team event in September.
- e. Numbers on the coaching programme were broadly similar.

- f. Memberships some IT issues meant that reminders couldn't be sent while the uncertainty about whether we would be continuing meant we did not actively recruit members this year. It is no longer mandatory for juniors to be club members to be on the coaching programme.
- g. Ladder currently 10 groups with 70 players. This is the most important aspect of membership for quite a few adults.
